The Nebraska State Board of Public Accountancy recently elected *Dr. Thomas Purcell, III, CPA*, Omaha, as Chair of the Board. Dr. Purcell is currently a Professor of Accounting in the Department of Accounting and Business Intelligence and Analytics in the Heider College of Business at Creighton University. He has taught tax, accounting and law at Creighton for more than 40 years. He currently serves the NASBA/AICPA Evolution Project as a member of the Tax Compliance & Planning Task Force, as well as the AICPA SSTS Revision Task Force. He previously has served in numerous leadership roles for both the AICPA and the Nebraska Society of CPAs, including chairing the AICPA Tax Executive Committee and the NSCPA Board of Directors. Dr. Purcell has authored numerous articles on tax responsibilities and tax policy and taught many CPE courses in Nebraska and other states. In 2010, he received the AICPA's Arthur Dixon Award, the highest award in taxation awarded by the AICPA, recognizing his excellence and longstanding service to the taxation profession. He has previously been recognized for his service by the Nebraska Society of CPAs and the Beta Alpha Psi Accounting National Honorary Society. He twice graduated from Creighton University (in both accounting and law), from the University of Missouri-Columbia with an MA in accounting and also the University of Nebraska, with a doctorate in accounting & taxation. He currently serves as Chair of the Board's Executive Committee, the Continuing Professional Education and Legislative Committee, and is a member the Education & Examination Committee. He has served as Vice Chair of the Board for the last three years and has been a member of the Board since 2014.

Ms. Marcy J. Luth, CPA, Grand Island, was elected Vice Chair of the Board. Ms. Luth is a shareholder with the CPA firm AMGL, P.C., located in Grand Island. She is a graduate of Hastings College and earned a Masters Degree in Business Administration from the University of Nebraska-Kearney.
