CPA's Fail to Renew Permits to Practice

Lincoln, Nebraska, July 25, 2005– The Nebraska Board of Public Accountancy has released the names of 16 Certified Public Accountants who have failed to renew their permits to practice for the licensing period effective July 1, 2005.

All persons holding a certificate as a Certified Public Accountant (CPA) from the State of Nebraska are required to maintain a license on a two-year basis. If they are practicing public accountancy or wishing to call themselves CPAs, they must have an active permit to practice. If they are not practicing public accountancy, they may keep their certificate as a Certified Public Accountant in good standing by registering with the Board of Public Accountancy on an "Inactive" basis.

The following are not eligible, as of July 1, 2005, to practice public accountancy or call themselves a certified public accountant and/or use the designation CPA. Any one with information that an individual is continuing to practice or hold out as a CPA after July 1 should contact the Nebraska Board of Public Accountancy.
